**Individuals are limited to one card in the Merlin system**, regardless of the place of issue. Patrons must fill out an application form and provide proof of identity and residence. A drivers' license, state identification card, or student ID may be used, or library staff may verify residence using the guidelines from the Wisconsin Proof of Residence for Voter Registration guide ([elections.wi.gov/publications/voter-guides/proof-of-residence](http://elections.wi.gov/publications/voter-guides/proof-of-residence)). Residents, property owners, and visitors to the area are eligible to apply for a library card. Each library in the Merlin Consortium shall provide the same services to all residents and property owners of the Northern Waters Library Service area as to residents. I understand when I borrow items from my home library that I agree to the lending and fine rules of my home library. I also understand that when I borrow items from other libraries in the Merlin Consortium or via Inter Library Loan, that I am agreeing to the lending and fine rules from those member libraries. Applicants under 18 years of age or adults with a legal guardian or caregiver must have a parent, guardian, or other adult serve as the responsible party for the card.
