

Why Mail-A-Book?

You are eligible for Mail-A-Book if you are homebound, physically disabled, or reside at least 15 miles from the closest library. Mail-A-Book offers the options to request library materials from your home to be delivered free of charge. A Mail-A-Book librarian is available to help you get the library materials you need. Materials are provided by the regional library members of Northern Waters and a state interlibrary loan program.



What services are included?

Library materials can be requested and renewed by phone, email, or online using the Northern Waters Library Network (NWLN) catalog shared by 29 libraries. Mail-A-Book cards are accepted at any of the public library members of NWLN. Your account will also give you access to quality licensed digital resources available through BadgerLink's discovery databases and Libby's downloadable media.

With Mail-A-Book you can have up to 10 movies, 8 music CD's, 20 audiobooks, 20 magazines, and 10 interlibrary loan items at a time. Northern Waters Library Network (NWLN) items can be renewed twice if there are no holds on the item. If NWLN doesn't have what you're looking for, we can check other Wisconsin libraries.

How to return items

Mail-A-Book items can be returned by mail at your expense, or to any NWLS member library. The following rural bookdrops are available free of charge.
